**Honorarium Admissible – Rs. 400/- per working day. (After engagement, if any). The work of PLV does not carry any salary, remuneration or wages.**

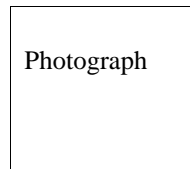
